

**OFFICIAL RULES**  
**Ferguson-Honeywell Pick-A-City Vacation Experience**

**To Enter:**

The Ferguson-Honeywell Pick-A-City Vacation Experience ("Sweepstakes") begins on October 1, 2017 and ends on November 30, 2017 ("Sweepstakes Period"). No purchase necessary to enter.

Automatic entry option: You will be automatically entered into the sweepstakes each time you purchase any six (6) Honeywell FocusPRO thermostats ("Qualifying Products"). No purchase total will be rounded up. For example, \$999 of Qualified Products gains one entry.

Alternate means of Entry to the Sweepstakes: You will be entered into the two Sweepstakes drawings upon receipt of a hand written 3 x 5 index card that provides your name, company name and account number, address and phone number. IMPORTANT: Entry cards received without company name and account number will be automatically disqualified. The prize will be awarded to principle on account.
